**Sub**: Sincere request from the Buddhists of India to stop DSI and Police harassment perpetuated on **Wat Dhammakaya Foundation**, THAILAND.

Your Excellency,

We, the Buddhists of India would like to bring our deep concern and pain to your kind notice that the Buddhist Monastery and Buddhist Institution viz. Wat Dhammakaya Foundation and its abbot Most Venerable Dhammajayo have been accused and targeted by the administration of Thailand on several charges which are said to be fabricated purely based on pre-conceived notions and prejudices and intellectual fallacies just to undermine and destroy the activities and humanitarian services of Wat Dhammakaya Foundation. Wat Dhammakaya Foundation has been carrying out commendable services around the world propagating Buddha Dhamma for the welfare and benefit of all. The training programmes conducted by trainers of Wat Dhammakaya Foundation are praiseworthy which infuses a sense of discipline and healthy life among the students, teachers, novices and monks across the globe.

As we know, after the **Mahaparinibbana** of Tathagata, the Gautama Buddha, there have been several schools of thoughts in Buddhism and they all co-existed in harmony and mutual support.
